GREETINGS: In the name of the State of Maine, you are hereby required to notify and warn the voters of the Town of Bridgton in said County and State, qualified by law to vote in town affairs to meet at the Town Hall located on North High Street in said Town on Tuesday, the 4th day of November, A.D. 2014 at 8:00 A.M. in the forenoon for the purpose of acting on Article 1 through Article 3 as set below. [The polls shall be open from 8:00 A.M. in the forenoon until 8:00 P.M. in the afternoon. The Registrar of Voters will hold office hours while the polls are open.]


Article 1. To elect a Moderator to preside at said Meeting and to vote by written ballot.


Article 2. To vote by secret ballot on the following "Question 1. Shall an Ordinance entitled "Town of Bridgton, Maine, Emergency Moratorium Ordinance on Marijuana Dispensaries and Sites of Marijuana Cultivation" be enacted?"


Article 3. To vote by secret ballot on the following "Question 2. Shall the Inhabitants of the Town of Bridgton accept the 2014 Comprehensive Plan, updating and replacing the 2004 Comprehensive Plan, direct its implementation, and further authorize the Town Manager to seek necessary approvals of this document from the State of Maine?"




