Article 1: Do you favor authorizing the board of directors of Maine School Administrative District No. 61 to issue bonds or notes in the name of this District for school construction purposes in an amount not to exceed \$7,880,000.00 to construct and equip additions and renovations to the Crooked River School on the existing school site on Route 11 in Casco?

The voting on Article 1 shall be by secret ballot referendum. The polls will be opened immediately after the election of the Moderator following commencement of the meeting at 8:00 A.M. and closed at 8:00 P.M.

The Registrar of Voters will hold office hours while the polls are open to correct any error in or change a name or address on the voting list; to accept the registration of any person eligible to vote and to accept new enrollments.

A person who is not registered as a voter may not vote in any election.
