Article 24. To see if the Town will vote to authorize the Board of Selectmen to enter into boundary line agreements with abutting property owners to establish the boundary line of any property of the Town, including the boundary lines of the rights-of-way of roads.

Article 25. To see if the Town will vote to authorize the Board of Selectmen to waive the foreclesure of a tax lien mortgage pursuant to 36 MRS § 944 upon a finding by the Board of Selectmen that ownership of the property subject to the lien would be contrary to the Town's best interest.

Article 26. To see if the Town will vote to authorize the Board of Selectmen, on behalf of the Town, to sell and dispose of any real estate acquired by the Town for non-payment of taxes thereou, on such terms as they deem advisable, and to execute quitclaim doeds for the property.

Property to be disposed of by written policy and on terms the Board of Selectmen deem advisable.

Motion was made by Selectman Packard to accept Article 26 as written; Second from Selectman McHatton. All in favor.

Article 26 was passed as written.

Article 27. To see if the Town will vote to authorize the Board of Selectmen, on behalf of the Town, to sell and dispose of any real estate acquired by the Town for non-payment of wastewater assessments thereon, on such terms as they deem advisable, and to execute quitclaim deeds for the property. Property to be disposed of by written policy and on terms the Board of Selectmen deem advisable.

Motion was made by Selectman McHatton to accept Article 27 as written; Second from Chairman Watkins. All in favor.

Article 27 was passed as written.

Article 28. To see if the Town will vote to authorize the Beard of Selectmen to sell Town-owned land that the Board of Selectmen has determined to be surplus, other than land acquired for non-payment of taxes or wastewater assessments, and to conduct the sale of such land by scaled bid, public auction or through an agent or multiple listing, whichever the Board of Selectmen deems to be in the best interest of the Town; and to deliver a quitclaim deed to the successful purchaser; provided that at least 30 days prior to selling, or obligating the Town to sell, such surplus land, the Town shall mail written notice to the abutters at their addresses on file with the Town, give notice on the Town's website, post at least one notice on a social media platform used by the Town, and publish at least one notice in a newspaper of general circulation in the Town. The net proceeds of any sale shall be deposited into the Town's general fund.

Board of Selectmen recommends a "Yes" vote.

Motion was made by Chairman Watkins to accept Article 28 as written; Second from Vice-Chairman Zaidman. All in favor.

Article 28 was passed as written.

Article 29. Voter-Petitioned Article. "REGARDING TOWN-OWNED PROPERTIES: All Town-owned properties to be sold shall be sold by announced auction and shall be advertised in the Bridgton News, the town website and all social media platforms controlled by the Town for a minimum of thirty days. The minimum sales price shall be no less than seventy percent of market value. Abutters shall be given written notice."

Beard of Selectmen recommends a "No" vote.

Motion was made by Vice-Chairman Zaidman to accept Article 29 as written; Second from Selectman Murphy. This Article was defeated.

Article 36. To see if the Town will vote to authorize the transfer of all unexpended balances to fund balance, excepting those carried forward funds, and to authorize any overdrafts that may occur in the Town operations in the 2018/2019 fiscal year to be taken from fund balance.

Article 31. To see if the Town will vote to authorize the Board of Selectmen to sell or dispose of equipment that is no longer of any use, or is annuable.

Motion was made by Selectman Packard to accept Article 31 as written; Second from Selectman McHatton. All in favor.

Article 31 was passed as written.

Article 32. To see if the Town will vote to authorize the Board of Selectmen and Treasurer, on behalf of the Town, to accept gifts, real estate, and funds, including trust funds, that may be given or left to the Town.

Motion was made by Selectman McHatton to accept Article 32 as written; Second from Chairman Watkins. All in favor.

Article 32 was passed as written.

Article 33. To see if the Town will vote to authorize the Board of Selectmen to apply for and accept grants on behalf of the Town, and to expend the proceeds thereof for the purposes for which they are received, provided that the terms of the grants do not require the Town to expend other funds which have not been appropriated by the Town.

Motion was made by Chairman Watkins to accept Article 33 as written; Second from Vice-Chairman Zaidman. All in favor.

Article 33 was passed as written.

Article 34. To see if the Town will vote to participate in the Cumberland County Housing and Community Development Programs of the Federal Department of Housing and Urban Development, including but not limited to the Community Development Block Grant Program (CDBG) and the HOME Program; to designate its population to be included in the calculation of Cumberland County's funds by the U.S. Department of Housing and Urban Development and to authorize the Board of Selectmen to execute an agreement with Cumberland County to formalize the same.

Motion was made by Vice-Chairman Zaidman to accept Article 34 as written; Second from Selectman Murphy. All in favor.

Article 34 was passed as written.
