Activities

The police department totaled 502 calls for service in June, with 17 motor vehicle accidents, 1 ATV accident, 16 disturbance calls, 4 domestic violence, 48 citizen assists, 7 juvenile problems, 31 alarms, 7 harassment complaints, 15 arrests, 90 traffic violations, 3 reports of thefts, 4 criminal mischief, 40 911 hang-ups, 14 animal problems, 19 checks for suspicious activity, 24 agency assists, 18 attempt to locate, 7 reports of fraud, and 9 welfare checks.

On June 9th and 10th the Bridgton Police held the second 'Cop on Top' at Hayes True Value. With the help of the Hayes family and generous donations from the public we raised over \$4,000.00 for Maine's Special Olympics. Sergeant Phil Jones has been instrumental in keeping the Bridgton Police at the forefront of this great charity.

The Town Manager hired our new Animal Control Officer, Brogan Horton. Brogan has great enthusiasm and much experience with all kinds of animal issues. We look forward to working with Brogan. We will miss Jackie Frye who took a full-time ACO position with Windham.

The Wellness Committee held its first employee cookout which was very well attended. It was a beautiful day and great food and conversation was had by all. The Deputy Town Manager and Police Chief won the first ever corn hole competition! Go Team!

The State of Maine's Department of Corrections conducted a second inspection of our cell in June as they had a change in personnel. The new inspector wanted to "see for himself" the cells that had been recently inspected. We passed without issue.

I attended Sherriff Joyce's staff meeting in June. This was an opportunity to meet his entire command staff and discuss issues of common concern. I very much appreciate the Sheriff's invitation.

In June, I attended the Maine Chiefs of Police Summer Conference where I presented the International Association of Chiefs of Police goals for the coming year. The conference was well attended with many new faces from all over Maine.

Our park Ranger, Brandan George, has been making a great impression at our beaches, parks and downtown by meeting with as many people as he can and being a great help to everyone.

We received seven applications for the police officer vacancy as of the deadline of July 1. We will be starting the process of interviewing and making a recommendation to the Town Manager in the coming months.

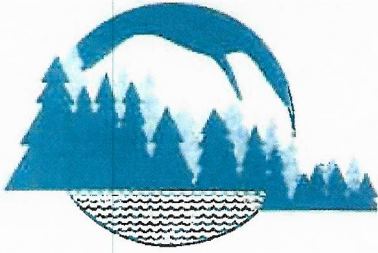
We also continued the work on the Burnham Road which was started last summer. This spring we ground the road surface and repaved the road finishing with new gravel shoulders.

MONTHLY REPORT

JUNE 2018

The investment committee met on Friday, June 8, and had a conference call with the representatives from Norway Savings Asset Management Group. This committee typically meets on a quarterly basis and plays an active role in the in overseeing the investments of the Moose Pond Trust, Park Forest Trust, and Bridgton Trust Funds.

The field auditor from Berry, Talbot, and Royer was on site both Mon., June 11 and Wed., June 13 to start preparing for the annual audit.

We had our annual town meeting on Wed., June 13 and even though it was a nice summer evening, it was well attended.

The safety committee met on Tues., June 12. I started developing a draft policy for a Fleet Safety Program and distributed copies to the committee members. The committee also reviewed the VDT Ergonomic Assessment Report for the assessment done on the front office area.

We had our monthly department head meeting on Tues., June 19. Our group talked about incident/accident reporting, timeliness of monthly department head reports, Office 365, MMA Online Training, and the capability of emailing paystubs to employees. New Selectman Day was Tues., June 26 and Thurs., June 28 for our newly elected Selectmen; Lee Eastman and Carmon Lone.

The wellness committee put together a BBQ to kick off summer on Thurs., June 21 for staff. Raffle drawings for a fish pole, kettle bells, BBQ set, and a small music boom box were held. Food was catered by Lake Region Caterers and was delicious; "Don't mind me if I have seconds." I played a game of corn hole with the Town Manager on my team and Chief Stillman and Georgiann on the other. Need to less to say, Chief Stillman is very good at this game.

On Saturday, June 30, I came in the office to set up the new Chart of Accounts for Revenues and Expenses in preparation of the start of the new fiscal year. This process included updating the Cash Recelpting Codes, Payroll Distribution Codes, and a few other relevant areas that impact the accounting systems.

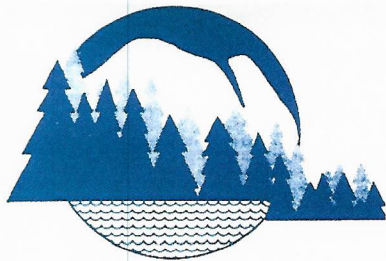
There were five payroll periods and several accounts payable warrants issued this month.

POLICE DEPARTMENT...The annual *Special Olympics Torch Run* took place on June 6th. It was well attended with cheers from the sidelines as the large group of participants made their way down Main Street. Each year the event seems to grow in size with support from local residents and businesses and those that want to be a part of the walk/run down Main Street.

TOWN MEETING....This year Town Meeting was on June 12th for referendum questions and June 13th for Town Meeting. 4 individuals ran for position of Selectman (3 year term); Liston E. Eastman, Jacqueline Frye, Carmen E. Lone and Robert J. McHatton. Elected were Carmen E. Lone with 702 votes and Listen E. Eastman with 505 votes. Elected Planning Board members for a 3 year term were Deanna Miller with 831 votes and Catherine J. Pinkham with 815 votes. Elected Planning Board members for 2 year term were Charles Kenneth Gibbs with 482 votes. Elected Planning Board Alternate Member for 3 year term were Doug Oakley with 44 write-in votes. Elected MSAD 61 Director for 3 year term were Karla J. Swanson Murphy with 1005 votes and Douglas Oakley with 5 write-in votes (declined the position). Elected Water District Trustee for 3 year term was Todd E. Perrault with 1017 votes. I would like to thank those that took the opportunity to run for these positions and wish those that were elected the very best of luck. On Wednesday, June 13th Town Meeting passed the proposed budget as presented.

BOARD OF SELECTMEN...On June 26th Liston "Lee" Eastman took part in *New Selectman Day* and on June 28th Carmen Lone took part in New Selectman Day. On these days a schedule is created for each Selectman to meet with Department Heads at their departments. It is an opportunity for the Selectman to better understand how a department functions on a daily basis. We have done this for several years and each year we receive positive feedback.

PERSONNEL....On June 2nd the Board of Selectmen hosted the *6th annual employee/committee/board barbecue* which is held at the Town Hall. The weather looked threatening at first but eventually the clouds let the sun shine in. The barbecue was well attended with raffles, music and good food. On June 21st the *Wellness Committee* hosted its first catered luncheon. The office was closed during lunch so employees could enjoy the afternoon outside and participate in games and a raffle and the food was delicious. The Police Chief and I won the first ever corn hole competition. I look forward to defending our title next year!!

On Tuesday June 12th at 7:34 pm an alarm was struck for 714 Upper Ridge Rd. The Chief had just left the Board of Selectmen's meeting and was on his way home. Being in his car, he immediately headed to the address which was reported as an "outside" fire. Upon his arrival, Chief Fay observed a large amount of smoke and two younger gentlemen running around in extremely high state of excitement.

The "outside" fire was up against the deck at the rear of the house and had started to consume a shed about 25 feet from the deck's corner. Flames had begun to impinge on the exterior of the home as well. Engine # 1 arrived approximately 2 minutes later and a solid knock down was begun. Fire by then had entered the interior of the shed and that was extinguished rapidly with no further loss to anything of value. When the incident was under control, about 500 gallons of water (1/2 of Engine # 1's tank) had been used. All this and a positive outcome is due to the fact that the response was met rapidly, personnel were on scene in a timely manner, and resources were deployed and utilized efficiently. Damage was contained to the shed and the stairs of the deck which will need to be replaced. Some cleaning and painting will be required to restore the deck back to its original condition.

This fire was the result of a camp fire that had gotten out of control in windy conditions on a ridge road. All this was a potential for disaster given the right circumstances. There had been **no** burn permit taken out for this particular fire. A camp fire is required by Maine State Law to have a burn permit. Permits are no fee and can be obtained at <http://www.burningpermit.com/meBridgton/> please read the instructions. Should you be unable to obtain the permit from your home, you can obtain one from Ashley in the Police Station or from Chief Fay at his office next door to the Police Station. The hours are Monday thru Friday 8:00 AM - 4:00 PM.

This is a reminder about the changes from the Maine Forest Service that have been implemented. The fire class assigned by them has changed from a numeric to a defined index. Classes 1,2,3,4 and 5 are reclassified to Low, Medium, High, Very High and Extreme. Burn permits will not be issued above a "Medium" classification. One other change was Bridgton going from Zone # 3 to Zone # 9.

The roof at Station # 4 was scheduled to be replaced beginning the first week of June. This project will begin sometime in July. Department members have begun to refurbish the airboat and have contributed over 40 man hours on the project. This is done on Sundays when members are available. There is one other project that we will complete when time avails and that is the finalization of the well project at Station # 6 out west.

The Bridgton Fire Department responded to a total of 31 incidents during the month of June. Below is the breakdown.

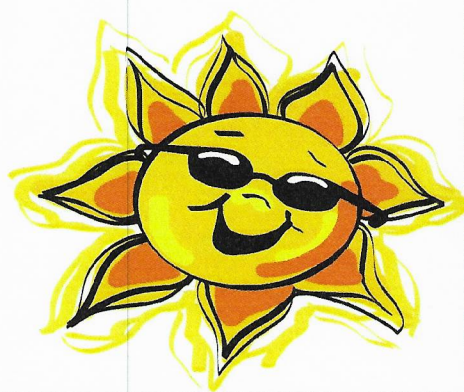

Question and Answers for

REC SUMMER CAMP

Q. How many staff members are there for summer camp?

A. There are 4 Youth Development Professionals and 1 Program Coordinator.

Q. What are the camp hours?

A. Camp is open Monday through Friday from 8AM to 5PM.

Q. Where is camp located?

A. Behind the Town Hall in the Bridgton Ice Rink.

Q. What age group can attend camp?

A. Entering Kindergarten through entering 6th Grade in Fall 2018

Q. What is the cost for summer camp?

A. \$80 per week for a Bridgton resident/taxpayer or \$110 per week for a Non-Resident. Additionally the cost of the weeks field trip.

Q. What activities does camp participate in during the summer?

A. Our goal is to keep each child active during the course of the day. We want to create ever lasting summer memories with fun interactive PE games, BOKS, swim techniques, arts and crafts, enrichment field trips, library trips, daily swimming, rainy day Magic Lantern visits and weekly hikes.

Q. Is there any scholarships available?

A. Yes in 2018 there is scholarships available. Please apply for scholarships before June 8th, 2018

Q. Is lunch & breakfast provided?

A. Each child will have the opportunity to have a free lunch and breakfast. Lunches come from MSAD 61. Typically, lunches are a sandwich or hot lunch, fruit, chocolate milk or milk, vegetable, and chips. Snacks should come from home and should be generally a healthier choice. Children should bring a second afternoon snack just in case they get hungry after swimming. We do have a share bowl where kids can have leftover breakfast and lunch from the day if they get hungry. We burn a ton of calories!!!

Q. Can my kids take both Swim Lessons and Summer Camp?

A. Campers will have a weekly session with a Water Safety Instructor to learn basic swimming and water survival skills. This modified session is offered to each camper as long as they attend camp. Campers can still take a desired swim lesson however it would be up to the parent/guardian to pick up and transport back and forth to the swim lesson of choice.

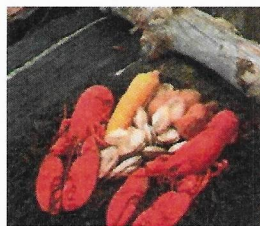

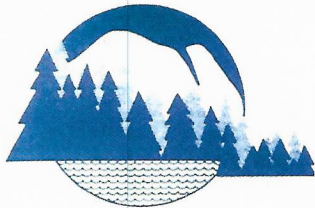

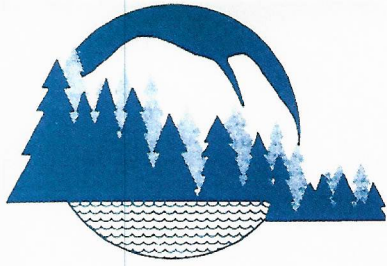
