## **Bridgton Police Department** **Monthly Report** **May 2019**

### **Activities**

*The police department totaled 560 calls for service in May, with 11 motor vehicle accidents, 3 disturbance calls, 3 domestic violence, 51 citizen assists, 28 alarms, 5 harassment complaints, 3 juvenile problems, 3 citizen disputes, 11 arrests, 190 traffic violations, 5 traffic hazards, 2 reports of thefts, 4 disabled motor vehicles, 1 bail checks, 2 criminal mischief, 39 911 hang-ups, 7 animal problems, 1 slide-offs, 11 checks for suspicious activity, 32 agency assists, 16 attempt to locate, 4 reports of fraud, and 20 welfare checks.*

### **Events**

We selected a candidate to replace for Officer Mac McCormick who left to join the Oxford County Sheriff's Department. We had nine applications and interviewed seven candidates. We are hoping to have both this new candidate and Reserve Officer George attend the Basic Law Enforcement Police Training academy in late July.

The department had it's third "Bridgton Youth Safety Day" on May 4<sup>th</sup> at the Stevens Brook Elementary School. Turned out to be a beautiful day and was very well attended. The Rotary donated youth bike helmets and had volunteers on hand to fit each child. Hannaford supplied food and drinks to attendees, The CCRCC had staff on hand to teach the proper use of 911, the Boy Scouts manned the bike safety course and had built houses and buildings of cardboard to simulate a real Town, MacDonald Motors made a significant donation to help defray costs and Dan Harden MC's the event including music. The Bridgton Fire Department had several vehicles and staff present as well as the Warden's Service and Fish & Game. Seven of our eight officers also participated. A big thanks to our Administrative Assistant, Ashley Bedard who worked tirelessly to put this together. Her and her husband donated a girl and boys bike to be raffled off by those who attended.

I continued to teach Eyewitness Identification to Law Enforcement Officers throughout the state and was privileged to go to York, Caribou and Ellsworth Maine. While in Caribou, Chief Mike Gahagan explained that I now could boast that I had in fact been to Maine since no one should make that claim without at least visiting "The County". So noted.

Officers spent a fair amount of time at the First/Last Hotel, making sure everyone was out per the Writ and checking on the premises. Former residents are still allowed to retrieve personal belongings until mid-June.
