Bridgton Planning Board Remote Procedure

1. Members of the public may participate remotely by using Zoom video.
2. Remote participants are muted upon entry by the zoom meeting host.
3. Recognition of remote participants:

 - b) If not able to have video on, use the zoom "raise hand" icon.
 - c) The meeting host will put participants in the queue to be recognized by the Chair. Once recognized by the Chair, the host will un-mute that participant.
 - d) During a public hearing, all public participants wishing to speak will be recognized first before anyone is recognized a second time.
4. Applicants must come in person. Applicant includes the person(s) representing the applicant.
5. Use of the zoom message function may only be done when there are technical issues, and if so, messaging must go to the meeting host.
