Events

An investigation led by Officer George resulted in a search warrant where 35 grams of suspected narcotics and firearms were seized.

Officer McCloud was recognized for outstanding performance as disarmed a suspect who presented a concealed handgun and pointed it at officers on scene of a disturbance.

Training

Bridgton PD hosted a regional training for Tactical Emergency Medical Care. Officers who attended received certifications in advanced first responder, Narcan, and epipen. Three Bridgton officers attended and at least ten others from agencies in Maine and New Hampshire. We have scheduled another similar training to again be held at the BPD.

Sergeants Reese and Muise received training as Axon Taser instructors.

Officers Regis, McCloud, and Chief Jones attended the Law Enforcement Torch Run conference held in South Portland.

Personnel

Officer Wilson continues in the Field Training Program. Officer George and Sgt. Muise oversee the program and evaluate the trainee as he responds to calls for service and tends to the various other duties officers are called upon to perform.

Officer Chaine has undertaken the responsibility of managing the evidence locker/property room. This is a heavy task to oversee, and he has extensive experience from his other agencies he has worked.
