Traffic and Parking Ordinance (formerly Traffic Ordinance)

The existing Bridgton Traffic Ordinance (BTO) and the Naples Traffic Ordinance (NTO) were used as references in constructing a new Traffic and Parking Ordinance for Bridgton.

- 3. **Definitions** (from NTO, “Public Way” {page 2, third paragraph})
- 4. Section/Article **Stopping, Standing, or Parking Prohibited in Specific Places** (from NTO, # 1-12); (remove “motorcycle” from intro paragraph); (add from BTO, “w/i 12” from curb” {in edited form} either as # 13 or included in # 1-12)
- 5. Section/Article **Obstruction of Free Passage** (from NTO, delete 3rd paragraph which goes to **Definitions** (in edited form)
- 6. Section/Article **Reverse Direction Parking Restricted** (from NTO)
- 7. Section/Article **Parking within Specified Allowable Times** (from NTO)
- 8. Section/Article **Snow Ban Parking Restrictions** (from NTO, with dates and times from BTO)
- 9. Section/Article **Removal of Vehicles at Owner’s Expense** (from NTO)
- 10. Section/Article **Sales/Advertising** (from NTO)
- 11. Section/Article **No Parking** (to be decided)
- 12. Section/Article **Disability Parking** (from NTO)
- 13. Section/Article **Restricted Parking** (to be created for: 1. Municipal Parking Lots, 2. Municipal Parks and 3. Municipal Complex,
- 14. Section/Article **Use of Sidewalks** (from NTO)
- 15. Section/Article **Notice** (from NTO)
- 16. Section/Article **Maintenance** (from NTO)
- 17. Section/Article **General Penalty** (from NTO with 2nd paragraph of Section XIII eliminated and Section XIV **Subsequent Penalty (ies)** added;

remove specific dollar amounts and replace with “as set by Select Board and/or statute”; add “attorneys’ fees and costs”)

- 18. Section/Article **Validity** (from NTO)
- 19. Section/Article **Enforcement** (from NTO, Town of “Bridgton” replaces Town of “Naples”)
