 - a. What can we tell citizens regarding other communities?
 - i. Each community varies
 - b. What issues are most important to Bridgton?
 - i. It is a tourist town That affects how the community feels
 - c. Negative letters to the editor
 - d. Double taxes?
 - i. Citizens are looking for a reduction in taxes or an increase in services.
 - ii. Is the bag revenue going back into taxes or services reserve funds?
 - 1. Specific issue funded with monies We need to find out what is paid.
 - 2. Do all funds go to the transfer station?
 - 3. All transfer station fees keep going up. PPB will ensure that our taxes do not keep going up to pay for these increases.
