SPECIAL TOWN MEETING RESULTS
Tuesday, November 8, 2022

Town Clerk Laurie Chadbourne called the meeting to order at 8:00 A.M.

Article 1. To elect a Moderator to preside at said meeting and to vote by written ballot. Marita Wisner was elected Moderator and sworn to the Statute Oath by Town Clerk Laurie Chadbourne. Moderator Wisner appointed Laura Ordway to serve as Deputy Moderator and Laura Ordway was sworn to the Statute Oath by Town Clerk Laurie Chadbourne.

Article 2. To elect the following Town Officers by secret ballot as required by 30-A MRS §2528:
