Community Development March 2023 Report

General Updates

The Arts & Culture Subcommittee organized another successful International Women's Day Flash Mob! This one was extra special, because it was dedicated in memory of Ursula Flaherty. She will always be remembered as a strong female leader in our community, and she spent a lot of time working with community development including chairing the CDAC. Great job A&C Subcommittee.

Community Development Block Grant (CDBG)

The selectboard held a public hearing and accepted the CDAC's funding recommendations for this program year. Nearly every year the committee has to work with an estimate, as HUD doesn't release the actual allocation until later in the year. The Bridgton Community Center Navigator program and Food Pantry were each allocated \$15,000 (subject to change per HUD funding) and the Church St. Sidewalk project was approved for \$130,000 (subject to change per HUD funding).

J Pratt will begin working on Highland and Elm Street sidewalks on April 10th and expect to wrap up both projects before May 15th. Please reach out to our department if you have questions on these projects. Our CDBG-funded infrastructure projects are:

Open Space Plan

Broadband

The team will continue to meet with ISPs and local broadband groups to provide more options to Bridgton residents. We will be developing a survey specific to broadband so local data can be used for grant applications this year. GPCOG, Maine Broadband Coalition, and the Bridgton Public Library held a great workshop on March 31st to collect feedback on people's experiences accessing high-speed internet to help inform state infrastructure investments. Grants & Other Funding Streams

Secured:

- CDBG annual allocation +/- \$200,000
- \$50,000 Governor's Office of Policy, Innovation, and the Future (GOPIF) allocated to our open space plan
- \$10,000 Community Heart and Soul Seed Grant allocated to community engagement process (Bridgton Public Library acts as the fiscal sponsor for this).
- \$8,000 from GPCOG to assist with the transportation chapter of Bridgton's comp plan

In Progress:

- 1.4 million EPA Earmark for Wastewater our office is working with finance and Woodard and Curran to submit all required documentation to receive funds. There will be a selectboard workshop on this matter.
- ARPA \$450k possible funding source for completing the wastewater extension project if approved

Ordinance Review Committee: ORC is reviewing the Traffic and Skateboard ordinances.
