General Updates

A few big events this April: Two new sidewalk projects started on Elm Street and Highland Road, and our RFP went live for the comprehensive plan!

Community Development Block Grant (CDBG)

As we wait to hear from Cumberland County on our final allocations for the year, our sidewalk projects are kicking off - J Pratt began working on Highland



and Elm Street sidewalks on April 10th and expect to wrap up both projects before May 15th. The photo to the left shows the Highland Beach Sidewalk, and to the right is the newly paved pathway through Shorey Park.

Comprehensive Plan / Vision Bridgton (VB)



Our department sent out the RFP for consulting services for the comprehensive plan update! We're excited to see a lot of bids on this important project! Meanwhile, *VB* is still in full swing collecting input from residents on what they want to see in their community 5-10 years down the road.

Open Space Plan

Viewshed, the consulting firm working on the plan, presented at the CDAC meeting on April 26th to show findings and part of the drafted plan. They will have the plan wrapped up in June! Please check out the website dedicated to the project; The link is posted on our webpage.

Broadband

The team will continue to meet with ISPs and local broadband groups to provide more options to Bridgton residents. This month, Spectrum applied for a grant through Maine Connectivity Authority to reach the currently unserved residents. Unfortunately, other towns were given priority due to higher numbers of unserved residents. We are looking forward to speaking with Consolidated Communications (also seen as Fidium) about their build-out scheduled for this summer.

Grants & Other Funding Streams

Secured:

- CDBG annual allocation +/- \$200,000
- \$50,000 Governor's Office of Policy, Innovation, and the Future (GOPIF) allocated to our open space plan
- \$10,000 Community Heart and Soul Seed Grant allocated to community engagement process (Bridgton Public Library acts as the fiscal sponsor for this)
- \$8,000 from GPCOG to assist with the transportation chapter of Bridgton's comp plan In Progress:
 - 1.4 million EPA Earmark for Wastewater our office is working with finance and Woodard and Curran to submit all required documentation to receive funds. There will be a selectboard workshop on this matter.
 - ARPA \$450k possible funding source for completing the wastewater extension project if approved

Community Development Advisory Committee: The CDAC is bringing in a series of guest speakers. Arts & Culture Subcommittee: A&C is planning Second Saturday Art Walks for the summer. Ordinance Review Committee: ORC is reviewing the Traffic and Skateboard ordinances. Planning Board (workshops): PB is reviewing LD 2003
